



Ultimate Miami Bartender Rules
Season 7 - 2018

Requirements:

- Applicant must be 21 years of age (or over) at time of entry.
- Applicant must live in Miami-Dade, Broward, Palm Beach or Monroe County and have a valid photo ID.
- Applicant must be currently employed as a bartender/mixologist at a bar, lounge, club, restaurant or as a Brand Ambassador in Miami-Dade, Broward, Palm Beach or Monroe County.
- Applicant must submit a completed Entry Form no later than Monday, April 16, 2018.
- If selected, Applicant must be available to attend a mandatory pre-event *contestant meeting* prior to the live competition on June 1, 2018.
 - The *contestant meeting* will take place on Monday, April 23, 2018 (official time TBD).
- If selected, Applicant must be available to compete in the live competition on June 1, 2018.
- If selected, Applicant must be available, willing and able to schedule and complete a filmed pre-event interview at Applicant's place of employment, with the producers of The Ultimate Miami series, at least two (2) weeks prior to the live competition on June 1, 2018.
 - This is a mandatory condition of entry and MUST be completed by all contestants.
- If selected, Applicant must sign an Audio/Visual Image Release Form prior to the live competition on June 1, 2018.
- If selected, Applicant must be available for the filming of the Ultimate Miami Reunion Show for Season 7 (official date TBD).

Competition Guidelines:

- The competition on June 1, 2018 consists of two live rounds:
 - In Round 1, each contestant will have a work station/bar inside Stage 305 (station assignments are determined at the pre-event *contestant meeting* mentioned above). Contestants are tasked with creating a signature cocktail, which will be served, as samples, to the general audience (maximum of 600). The general audience will sample each signature cocktail and vote for their favorite. The contestants are responsible for bringing all equipment and non-alcoholic ingredients necessary for Round 1. Ultimate Miami, LLC will provide the contestants with the sampling cups and all alcoholic ingredients needed to create their signature cocktails. Ultimate Miami, LLC will also provide contestants with a stipend to purchase non-alcoholic ingredients (more details will be provided at the *contestant meeting*). The contestants are allowed to have one (1) assistant present during the preparation and distribution of the signature cocktails in Round 1. Assistants must be over 21 years of age.
 - In Round 2, the competition is narrowed down to two (2) final contestants with the most audience votes. The two finalists are given 4 minutes to craft a cocktail on the main stage, for three (3) official judges, in front of a live audience. Ultimate Miami, LLC provides each of the finalists with a fully stocked bar, plus all equipment and ingredients necessary for Round 2.
- The three (3) official Round 2 judges will choose the ultimate winner of Ultimate Miami Bartender.
- If selected, contestants must submit the recipe for their signature cocktail to Ultimate Miami, LLC by the pre-event contestant meeting on April 23, 2018.
- All judges' decisions are final.
- Grand Prize: \$5,000
- 2nd Place: \$500

Eligibility will be determined by Ultimate Miami in its sole and absolute discretion.
Management reserves the right to alter the rules and requirements of the competition.
